## Iowa Interstate Chairman Posner Uses Russian Skills to Help Ukrainian Refugees on German Evacuation Train

The Russian invasion of Ukraine has prompted many U.S. companies to look for ways to help those affected by the conflict, particularly the

millions of refugees who have fled the country in search of safety.

Henry Posner III, chairman of Railroad Development Corporation (RDC), ASLRRA member Iowa Interstate Railroad and RDC-Deutschland (RDC-D), among other companies, <u>recently had a firsthand role</u> in efforts to transport Ukrainian refugees in Germany. Posner was in the country on a planned trip when the opportunity to help arose.

On March 12, Posner worked as a Russian translator on an RDC-D train carrying 480 Ukrainians from the city of Frankfurt/Oder on the Polish-German border to Hannover, where a reception center to welcome and process refugees was set up in a large exhibition hall. Posner was one of only two Russian speakers on the train that day.

"I was very proud to be associated with what our team is accomplishing," said Posner. "And I was also proud to have had a working role, actually being able to help and not just getting in the way."

After completing the arrival process, refugees were free to travel on to their final destinations, often the homes of friends, family or acquaintances. Germany and other European Union members are currently offering free rail transportation to anyone with a Ukrainian passport or official ID.

Private railroad company RDC-D is a subsidiary of Pittsburgh, Pennsylvaniabased RDC and operates passenger trains in Germany. The German government reached out to RDC-D in early March to set up an evacuation route for Ukrainian refugees in Poland, and on March 10 the first train completed a three-

hour journey with over 600 passengers, a five-member crew and employees of the Deutsches Rotes Kreuz, or German Red Cross.

Passenger operations in Germany are much more flexible than in the U.S., and availability of rolling stock, crewmembers and staff allowed RDC-D to set up operations quickly. RDC-D has had experience with these types of emergency routes in other situations, which further enabled the company to meet the government's request. The German government is covering all of RDC-D's operating costs as part of the country's Ukrainian relief efforts.

For now, RDC-D plans on running one train a day for the foreseeable future, although it is possible additional trains may be added if needed.

"We are taking this literally on a day-by-day basis," said Posner.

Though he is now back in the states, Posner is not done helping. Instead of working with crewmembers on the train, he provides assistance by making connections to help meet needs as they arise, relying more on his email skills than his Russian.

To that end, Posner, in conjunction with Ukrainian friends and colleagues, offers suggestions for those in America who want to help Ukrainian refugees. Follow this link for the full document.

#### Posner writes:

- 1. **Provide more direct financial support.** In the short term, we encourage people to reach out to any Ukrainian friends or colleagues to provide direct financial support to smaller, trusted organizations or individuals in Ukraine.
- 2. **Support remote work and employment of Ukrainians.** Stable employment can be one of the most helpful factors for those who have been displaced. Many Ukrainians have both English language skills and technical skills including railway-related skills.
- 3. **Contribute to a trusted charity providing humanitarian response**. The following organizations are providing on-the-ground response:
  - a. International Rescue Committee
  - b. Save the Children

- c. Americares
- 4. Finally, be kind to Russians. This is not their war. This is [Russian President Vladimir] Putin's war.

#### **Comments on FRA Program Urge Thorough Impact Assessment**

ASLRRA submitted <u>comments</u> in response to the Federal Railroad Administration's <u>Request for Information</u> (RFI) regarding the Corridor Identification and Development Program.

The program "creates a new framework to facilitate the development of new, enhanced, and restored intercity passenger rail corridors throughout the country." In its comments, ASLRRA emphasizes that some of the Association's short line members successfully host

passenger rail service now, while others would welcome collaborative conversations about hosting new or expanded passenger services.

ASLRRA cautions, however, that any new proposals should address potential impacts, and the Association suggests certain principles be followed to best evaluate potential new or expanded passenger rail operations on host short line railroads. The principles focus on safety, access and capacity, full compensation and risk mitigation and a customized approach.

#### Railroad Members Encouraged to Comment on State Rail Plans

Several states are currently updating their state rail plans for 2022 and are in the process of collecting input from rail stakeholders. ASLRRA encourages its members to participate in their state's planning process to help ensure the needs of the short line freight rail industry are heard.

Missouri recently issued a draft of its state plan, with a <u>public comment period</u> open until March 31. South Dakota is also drafting its <u>2022 state plan</u>. Stakeholders can navigate an online public meeting, submit comments online or view a schedule of in-person public meetings.

Other states working on rail plans for this year include <u>California</u>, <u>Virginia</u>, <u>New Jersey</u> and more. The Federal Railroad Administration (FRA) does not require states or the District of Columbia to prepare and maintain a plan, but <u>encourages</u> states to do so. Many states developed their current plans in 2017, which puts them on track for this year's updates.



#### \$1.5T Omnibus Passes Senate, Signed into Law by President Biden

Late last week, the U.S. Senate passed the \$1.5 trillion omnibus spending package by a 68-31 margin to keep the government funded through the end of fiscal year 2022. The bill already passed the House earlier in the week, and the Senate's passage of the measure cleared it for the President who signed it into law.

The bill is a big win for the short line freight rail industry, as it provides additional resources beyond the already robust funds that were provided in the infrastructure bill that passed Congress late last year.

Specifically, the measure provides significantly more funding for programs like CRISI for which Class II and Class III railroads can directly compete, or the Port Infrastructure Development Program and RAISE for which short line railroads can work with state and local partners to advance projects that could benefit short line freight rail. The bill also provides resources for programs like the Short Line Safety Institute and contains helpful language regarding truck size and weights.

#### Some Railroad Day Meetings Carry Over into This Week and Next





#### Safety Performance Turnaround Demonstrates Achievements Worth Recognizing

Some railroads might see a year with zero injuries as a common occurrence, but for ASLRRA member parent company Pioneer Lines, marking one year with zero injuries across all its 15 short line subsidiaries is a significant milestone.

In 2018 the injury rate at Pioneer Lines was 15.96 injuries per 200,000 employee on-duty hours, compared to the industry-average rate of 2.18 injuries per 200,000 hours. When a new leadership team took the helm at Pioneer Lines in 2019, improving company safety was one of its highest priorities.

Pioneer Lines adopted several initiatives to build a strong safety culture and introduced a company-wide effort focused on the ideas of "responsibility, accountability, and commitment to excellence," resulting in the drop to zero injuries in only a few years.

"To have all our railroads reach this goal in such a small amount of time is an indication of the incredible men and women at Pioneer. This was a collective effort, and I am extremely proud of our team's dedication to operating safely," said Pioneer Lines Chief Operating Officer Ross Grantham in a <u>press</u> release.

The achievements of Pioneer Lines demonstrate the commitment to safety culture ASLRRA wants to recognize among its railroad members through its annual award program. In addition to the Association's Jake Awards and President's Awards, ASLRRA honors individuals who make significant contributions to their company's safety programs and safety culture.

The nomination period for ASLRRA's Safety Person of the Year and Safety Professional of the Year awards has been extended until March 18. ASLRRA encourages its members to nominate noteworthy employees through the simple online form linked below. #### Thank You to All Who Helped Make Railroad Day 2022 a Success

ASLRRA thanks all those who participated in last week's Railroad Day on Capitol Hill virtual meetings. More than 350 participants spoke via Zoom with over 220 congressional offices, urging their representatives to support full funding and streamlined implementation of the Infrastructure Investment and Jobs Act (IIJA), also known as the Bipartisan Infrastructure Law (BIL); preserve balanced economic regulation; and oppose all efforts to increase truck length or weight limits.

Aside from the contacts made directly through Zoom meetings, the rail industry connected with a wide audience on its social media profiles and through coordination with the social media efforts of partner organizations like the Association of American Railroads and GoRail.

The Railday2022 hashtag was used more than 500 times, generating 734,000 impressions. ASLRRA's Railroad Day posts on Twitter generated 46,896 organic impressions, or views, and over 1,000 engagements, which includes likes, retweets and comments.

These counts do not include posts in which ASLRRA was tagged, which generated even more impressions and engagement across multiple Twitter accounts. Several of the congressional representatives who participated in Railroad Day meetings saw the posts tagging them on Twitter and engaged with them, primarily through likes. Others, such as <u>Sen. Patrick Leahy</u>, <u>Rep. Chuy Garcia</u> and <u>Rep. Dutch Ruppersberger</u>, retweeted posts with comments or wrote their own comments about Railroad Day and tagged ASLRRA and others.

#### Save the Date for ASLRRA's Summer Training Seminars

The <u>Comprehensive General Code of Operating Rules (GCOR) Training Seminar</u> takes place July 26 to 28 in Cedar Falls, Iowa. ASLRRA has partnered with Iowa Northern Railway to help railroads meet operating rules training required by 49 CFR Part 240, 242 and 214 Subpart C.
