Railroad Day on Capitol Hill Concludes

Armed with fact sheets and personal anecdotes, representatives from all facets of the railroad industry met with federal lawmakers and their staffers yesterday and today during Railroad Day on Capitol Hill. This was the first year that the event was held via Zoom.

"Railroad Day on the Hill is our industry's time to focus Congress on the benefits we provide and the issues that should be addressed to allow freight railroads to help keep moving our nation's economic recovery forward," said ASLRRA President Chuck Baker.

"Holding the days via Zoom this year allowed us to continue with this beloved annual tradition, and it gave more than 260 Congressional offices the opportunity to interact with 475 constituent railroaders that are directly impacted by federal legislation and regulation made in Washington. The nation's freight rail industry - short lines, Class Is, labor, contractors, and suppliers all together - is positioned to help America meet many crucial objectives - safe, efficient, and environmentally friendly transportation that helps grow the economy, rebuild the middle class, and allows American businesses to compete and win on the global stage. We connect America's small towns and rural areas to the nation's largest cities and ports, and are looking forward to continuing to work with Congress on policies that allow us do that safely and efficiently."

Participants discussed the contributions of railroads to the overall strength and resilience of the U.S. supply chain, particularly during the COVID-19 pandemic and highlighted three legislative asks.

The railroad industry thanks all those who participated in this year's meetings, and those who acted as meeting hosts and leaders. DOT Issues Notice of Funding Opportunity for RAISE Grant Program

The U.S. Department of Transportation (DOT) <u>issued</u> a <u>notice of funding opportunity</u> (NOFO) for the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant program. The RAISE program has previously been known as the BUILD and TIGER grants.

This year, \$1 billion in grant funding will be available through the RAISE program, which will be awarded to infrastructure investment projects with a significant local or regional impact. Funding will be split equally between projects in urban and rural areas.

To help with the application process, the DOT will host several webinars for interested parties. Registration can be completed <u>here</u>, once the webinar dates and times have been finalized. Applications for RAISE grants are due July 12.

<u>comments</u> in response to the National Highway Traffic Safety Administration's (NHTSA) <u>advance notice of proposed rulemaking</u> addressing Automated Driving Systems (ADS) safety for motor vehicles.

The NHTSA sought comment on its development of a framework to define, assess and manage the safety of ADS performance while making sure to allow flexibility for future innovation.

In their comments, ASLRRA and AAR requested that all U.S. Department of Transportation agencies, such as the NHTSA, take a consistent approach toward safety advancements and technological innovation related to the development of autonomous technology across the various modes of transportation, including for railroads.

The associations noted that the public will benefit from technology-driven safety gains in rail and other industries, and that a mode-neutral regulatory approach will ensure a level playing field among all transportation options. Additionally, ASLRRA and AAR commented that, to maximize the safety benefits of ADS technology, it must be designed to recognize highway-rail grade crossings and respond appropriately to active and passive grade crossing warning devices and approaching trains.

STB Final Rule Exempts Small Railroads from New Demurrage Invoice Requirements

The Surface Transportation Board (STB) <u>issued</u> a <u>final rule</u> requiring Class I carriers to include certain information on or with demurrage invoices and provide machine-readable access to that information.

The decision is positive news for short lines, as the STB declined to extend these demurrage requirements to Class II and III railroads. ASLRRA commented on the initial proposed rule in 2019 arguing that the regulation should not apply to Class II and III railroads because the demurrage issues raised by stakeholders mostly pertained to Class I carriers and meeting the proposed requirements would place an undue burden on small railroads.

Still, the STB encourages Class II and III carriers to comply with the final rule to the extent they are able.

AAR RAN Security Note and CISA Cybersecurity Tool Available on ASLRRA Website

Several new <u>security alerts</u> are now available to members on ASLRRA's website. They include an Association of American Railroads (AAR) Railway Alert Network (RAN) Security Awareness Note and information about a new Cybersecurity and Infrastructure Security Agency (CISA) resource to help detect compromised accounts.

The AAR security notes discuss track shunting incidents in 2020 and recent intentional interference with railroad infrastructure incidents.

The CISA document discusses "Aviary," a companion resource to CISA's Sparrow detection tool that provides a more user-friendly dashboard to show data collected by Sparrow concerning cyber attacks.

ASLRRA Joins Rebuild Rural Coalition Comments on Biden's Proposed Infrastructure Plan

The Rebuild Rural Infrastructure Coalition released a <u>statement</u> on President Biden's infrastructure plan, saying that the proposal "offers a good starting point for discussions with Congress."

Rebuild Rural urges a bipartisan approach to infrastructure legislation that makes sure to take into account the needs of rural communities and rural infrastructure. It also encourages lawmakers to continue utilizing existing federal programs that have proven to

be successful.
