### Infrastructure Bill Passes Senate, Sent to House, Turns Attention to Budget Resolution

The Senate voted Tuesday to pass the Infrastructure Investment and Jobs Act (IIJA). It will now go to the House, but whether and when the House will act on it depends on what actions the Senate takes regarding the budget reconciliation process.

As it stands, the Senate's proposal is excellent for short lines, and ASLRRA issued a <u>statement</u> to that effect on Tuesday. There are multiple attractive funding opportunities, particularly through the Consolidated Rail Infrastructure and Safety Improvements (CRISI) grant program. The Senate also leaves out troubling policy provisions, like a crew-size mandate and blocked crossings fines.

The Senate also completed debate on a larger \$3.5 trillion budget resolution, and individual Senate committees are now tasked with filling out the details of the budget package in the coming weeks before the Senate votes again - likely in September or October but by then it will be a more specific, detailed bill and include much more fleshed out policy.

The House has indicated an unwillingness to consider the IIJA without this broader budget bill that addresses other Democratic priorities like social welfare, with support for child care, paid family leave and pre-kindergarten education. Senate Democrats plan to use the budget reconciliation process to circumvent Republican opposition to the budget resolution.

There is no telling whether the House will try to change the Senate's infrastructure bill before sending it to the president's desk, as House Transportation and Infrastructure Committee Chairman Peter DeFazio (D-Ore.) would prefer, or whether the House will simply pass the bill as-is and then forward it to the President's desk for signature, which is what the Senate, many House moderates and the White House would prefer. ASLRRA's legislative and government affairs team will be keeping tabs on the bill and its potential impact on the short line freight rail industry, and will continue working to preserve the many great elements of the bill.

### North Carolina DOT Grant Funds Awarded to ASLRRA Members

### RAN Message Concerning CDC's Face-Mask Guidance Available on ASLRRA's Website

ASLRRA has posted on its website an Association of American Railroads (AAR) Railway Alert Network (RAN) Situational Awareness Message concerning wearing facial coverings indoors. Members are able to log in and view the message here.

The Centers for Disease Control and Prevention (CDC) issued revised guidance on wearing face coverings indoors due to a significant rise in COVID-19 infections nationwide, caused in large part by the highly contagious delta variant. The CDC recommends all people, including those fully vaccinated against COVID-19, wear a mask in public indoor settings in areas of substantial or high disease transmission.

The CDC's <u>website</u> features a map indicating transmission status in each state, according to county or parish. Information is also included for Washington, D.C. and Puerto Rico.



### ASLRRA Statement Supports the IIJA, Encourages Swift Action

ASLRRA has <u>issued a statement</u> in response to yesterday's Senate vote passing the Infrastructure Investment and Jobs Act.

"Today's Senate passage of the Infrastructure Investment and Jobs Act (IIJA) is the culmination of many months of measured consideration and bipartisan work to provide a certain path forward on improving infrastructure, ensuring economic recovery and U.S. supply chain competitiveness. The IIJA recognizes small business

freight railroads as an integral and essential piece of the freight rail network, helping to move America forward by serving tens of thousands of shippers and supporting the small town, rural and urban communities in which they operate while minimizing greenhouse gas emissions and reducing wear and tear on the nation's roads. This measure marks unprecedented levels of investment in programs that are critical to our freight industry - like CRISI, RAISE, and INFRA - providing our members enormously expanded opportunities to compete for investment grants to implement new technology, upgrade aging track, rehabilitate bridges, and initiate important safety measures that allow us to better serve our customers. We commend the Senate for advancing this bold, bipartisan bill - and for avoiding needless policy mandates that would hinder our ability to serve the industries that rely on us. We now urge the U.S. House of Representatives to work to swiftly move this legislation to the President's desk," said ASLRRA President Chuck Baker.

### Use ASLRRA's Disaster Preparedness Resources to Get Ready for Potential Adverse Events

Hurricane season is underway, and wildfires continue to burn across the western United States. These disasters and others can all cause widespread damage to the national rail network, wreaking havoc and disrupting normal business operations for weeks and even months. The potential human, community and economic impact underscores the critical need for railroads to have an emergency plan that can be activated on short notice as well as quick access to resources and emergency relief services to facilitate a return to normal operations as quickly as possible.

With support from railroad and supplier members, ASLRRA has assembled essential templates and checklists to assist members in developing response plans that can be put in place and used as training tools before disaster strikes, as well as emergency response tools and resources to aid in the recovery process in the aftermath of a catastrophic event.

#### ASLRRA Out and About

#### Gitchell, Radford Discuss Short Line Priorities with Staff for LA Representative

ASLRRA's Assistant Vice President of Legislative and Regulatory Policy Crystal Gitchell and Assistant Vice President of Congressional Affairs Zach Radford met with staff for Representative Troy Carter (D-La.) in Washington, D.C. last week to discuss the short line freight rail industry's key priorities as Congress advances infrastructure legislation.

Carter took office in May 2021 and earned seats on the Transportation and Infrastructure Committee, including the railroads subcommittee, and the Committee on Small Business. His district includes several short line railroads and ASLRRA is eager to host the newly elected congressman and his staff for some site visits in the future.

## Baker's New Column Explains the Importance of CRISI Grants to Short Line Freight Rail

In his <u>column</u> in *Railway Age* magazine's August issue, ASLRRA President Chuck Baker hones in on federal railroad infrastructure grants, specifically the Consolidated Rail Infrastructure and Safety Improvements (CRISI) Program.

Baker explains that, from a short line perspective, CRISI grants are "the most important" of currently available federal programs. It is the only funding program for which short lines are directly eligible to apply, and Baker is encouraged by the CRISI funding provided in the Senate's Infrastructure Investment and Jobs Act.

The column goes on to highlight four key ways CRISI funding is vital to small railroads and includes an example from ASLRRA member Iowa Interstate Railroad (IAIS), showing how IAIS used a \$3.47 million CRISI grant to help replace a 121-year-old bridge over which moves almost 8,000 carloads annually.

#### **SMART Seeks Operators Interested in California Short Line**

Sonoma-Marin Area Rail Transit (SMART), an ASLRRA member that operates passenger service, is exploring the option of contracting out a short line operation to a third party.

SMART recently received approval from the Surface Transportation Board to become a common carrier for freight and take over the existing operation from the Northwestern Pacific Railroad, a line that is discontinuing operations. In an effort to gauge potential interest in the freight rail operation, SMART issued a Request for Information (RFI), sharing details about the opportunity and requesting feedback.
