NOMINATIONS SOUGHT FOR ASLRRRA SAFETY AWARDS

Nominations are now being accepted for ASLRRRA's two safety awards: **Safety Person of the Year** and **Most Improved Railroad**. The winners of these awards will be honored at the ASLRRRA Annual Convention in Orlando this coming May.

The **Safety Person of the Year Award** will recognize the small railroad employee who has demonstrated outstanding safety achievement, with special emphasis on initiatives that improve employee safety in the workplace. Any employee of an ASLRRRA member railroad may be a candidate for this award. Among the considerations in selecting the winner of this award will be that the nominee has never sustained an FRA-reportable injury and has exhibited a high degree of safety awareness through visible promotion of safety programs and initiatives.

The **Most Improved Railroad Award** has undergone a change in the way it will be adjudicated this year. Unlike in previous years, when the award was given based solely on the railroad's FRA Frequency Severity Index score, the recipient of this year's award will be decided through a criteria-based selection process. This criteria includes: demonstration of improved safety over a period of at least three years; evidence of implementation of programs, processes and procedures that have resulted in a marked improvement in safety; and explanation of the "capital" (i.e. manpower, funding, related resources, etc.) that have been devoted to improving safety.

Nominations for **Safety Person of the Year** should be sent as a letter on company letterhead and signed by the CEO of the nominated individual's railroad. Nomination letters for Safety Person Of The Year should be sent to:

FRA's SZABO ASKS RAILROADERS TO FOCUS ON SAFETY

In a special letter sent January 26, FRA Chief Administrator Joe Szabo called for all U.S. rail industry employees to make the maximum effort to work safely on the job. Mr. Szabo noted in his letter that, although preliminary reports indicate that 2009 may have been the safest year on record, there were nevertheless 16 on-duty fatalities during the year. The text of Mr. Szabo's letter follows:

“Dear Colleague:

“Preliminary data indicates that 2009 may have been the safest year on record by many measures. This accomplishment is the result of the diligent and sustained efforts of rail labor, rail management, and the Federal Railroad Administration (FRA). I thank you and commend you for your role in this accomplishment.

“The news is not uniformly good, however. Last year, 16 railroad employees were killed on the job. This tragic toll is more than just a number; it represents human lives: a father not there to walk his daughter down the aisle, a mother not there for her son's first day of school, an employee nearing retirement who did not live to enjoy the fruits of his labor.

“As the new year begins, I'm asking each of you to use your time and talents to help eliminate railroad employee fatalities. In this world of instant communication and technology and information "overload," we need to maintain complete situational awareness. Keep your mind clear of distractions-keep cell phones and other devices turned off- and focus on the task at hand. The railroad environment is totally unforgiving and the slightest lapse could be tragic.

“We need to think about rules compliance and consider its impact on ensuring a safe return home after each tour of duty. We must break down the barriers that keep us from achieving rules compliance, like taking a shortcut or yielding to pressure from a supervisor to unsafely expedite a move. We must take the time to ensure each rule is complied with, and mentor fellow coworkers. Remind them that it is all about going home safely, and if you are pressured by a supervisor to expedite a move by turning your back on the rules, report it. FRA will work diligently to ensure that the focus on rules compliance is consistent within each carrier's organization.

“Having spent 19 years on the ground myself, I – like you – understand the realities of railroading. My stomach still turns in knots each time I hear of an on-duty fatality. Let us each do everything we can to take care of ourselves and our coworkers. Zero fatalities is the only acceptable number, and it's a number we can all live with.

DEADLINE APPROACHING FOR CWR COMPLIANCE BY CLASS 3 RAILROADS

The date is February 22 for compliance with the new continuous welded rail (CWR) regulations by Class 3 railroads. These regs were released last August 25 by the Federal Railroad Administration. They are already effective for Class 1 and 2 railroads.

Requirements of the new CWR regs include the following, which are excerpted from the newsletter of NRCMA Board Member John Zusan:

- A qualified person that inspects or supervises the installation, adjustment, or maintenance of CWR must complete a comprehensive training course and demonstrate his understanding of CWR.
- Fines for non-compliance have risen from a maximum of \$650 per violation to \$25,000 per violation. Willful violation has risen from \$27,000 to \$100,000.
- A CWR track owner must have a written CWR plan in place. The plan must be approved by the FRA.
- A bolted joint in CWR installed after August 25, 2009 must be welded within 60 days.
- A CWR track owner must establish a range (working range) that causes track buckling.
- A CWR track owner must determine areas that are prone to buckles and pull-aparts.
- A “Fracture Report” is now required for every broken joint bar. This report needs to be submitted to the FRA twice annually.
- A CWR track owner must have a training program that includes written procedures and provisions for annual re-training.
- A CWR track owner must also have a CWR standards and procedures manual at every location of CWR track.

FRA ISSUES SPECIAL ADVISORY ON CROSSINGS

The Federal Railroad Administration has issued a special safety advisory related to the identification and handling of highway-rail grade crossings with vertical profile conditions. The advisory, formally designated FRA Safety Advisory 2009-03, was issued December 31, 2009 and was published in the Federal Register on January 22, 2010.

The advisory recommends that each state “identify public highway-rail grade crossing where Low Ground Clearance signs have been installed and submit updated data on these crossings to the [U.S.] DOT Crossing Inventory.” It further recommends that the states implement policies and procedures to identify public highway-rail grade crossings that do not satisfy the American Association of State Highway and Transportation Officials’ Policy on Geometric Design of Highways and Streets (a.k.a. the “AASHTO Green Book”) and asks

that corrective action be taken to bring them into compliance.

The advisory references earlier U.S. National Transportation Board Safety Recommendations H-96-01, 02 and 04. Its issuance follows a related action taken in December by the Transportation Safety Board of Canada in response to a recent Canadian accident, in which a low-clearance truck became impaled on a crossing and was then struck by an approaching train.

FRA SOFA GROUP TO PRESENT SWITCHING FATALITY FINDINGS

The Federal Railroad Administration has announced that its Switching Operation Fatality Analysis (SOFA) Working Group will present its initial findings to the rail industry in a special meeting to be held the afternoon of Railroad Day On Capitol Hill, February 25. In a letter sent to rail industry leadership, FRA Chief Administrator Joe Szabo – himself a member of the group immediately prior to his appointment as FRA head – has invited them to Washington to “discuss some of SOFA’s latest findings; the actions we, as an industry, can take to address those findings; and what measures will be taken to monitor progress in creating a safer workplace for operating crews that work in yards, industries, and along the mainlines of our Nation.”

The SOFA group was first convened by FRA in 1998 to examine the 76 fatalities that involved railroad employees engaged in switching operations between January 1, 1992 and July 1, 1998. That group’s findings included five operating recommendations, later shortened to “5 Livesavers” that are now in widespread use throughout the industry: Secure equipment before action is taken; protect employees against moving equipment; discuss safety at the beginning of a job or when a project changes; communicate before action is taken; and mentor less experienced employees to perform service safety. The group was reconvened by FRA in 2004 and then again in early 2009, on both occasions a response to switching-related fatalities having unfortunately continued to occur.

The current SOFA group is made up of eleven career railroaders, who altogether total over 300 man-years’ industry experience, and is assisted by three high-level consultants. Additional to its FRA facilitators, the group includes representatives from the Brotherhood of Locomotive Engineers & Trainmen, the United Transportation Union, the Association of American Railroads, and the American Short Line and Regional Railroad Association. Participating for ASLRRA have been Tom Streicher and Dave Mears. Dave says that the group is “far and away” the most effective labor-management team he has ever been involved with. “The level of synergy coming out of the group is truly remarkable,” he says. “There is no defensive posturing whatsoever. If, for example, the group’s examination of a switching fatality reveals that it was due in some degree to human error, no one disputes it.” Dave says that participating in the group has had special meaning for him due to his maternal grandfather having lost part of his leg while switching cars for the old Pittsburgh & Lake Erie Railroad in the 1930s. “My involvement here gives me a chance not only to honor his memory, but also to try to make sure that what happened to him stops happening to others,” he said.

Additional to having been given special access to FRA case documentation, the group has employed the latest technological innovations in its work. A recent case examination saw the use of the satellite map tool Google Earth, which was displayed on the screen to give the group an aerial view of the site where a switching fatality occurred. This assisted the group in familiarizing themselves with the accident location and the physical sequence of events that led up to it, as well as allowing them to check for anything unique to the site that may have contributed to the accident.

The group has now completed its detailed examination of 55 switching fatalities occurring between January 1, 2004 and December 31, 2009. It has also entered them into an advanced database management system, and is presently using that system to deduce the commonalities and other relational elements present among them. From this work will come recommendations that will – as stated with both hopefulness and expectation in Mr. Szabo’s letter – “if implemented, reduce these types of fatalities to zero.”

FEDS AWARD \$8 BILLION FOR PASSENGER RAIL

On Wednesday, January 27, President Obama and key members of his administration announced the particulars of federal funding grants for the construction or improvement of selected U.S. passenger rail services. The funding was called for by last year’s American Recovery & Reinvestment Act (ARRA) and totals approximately \$8 billion.

A total of 79 projects will be funded in a total of 31 states. Regionally, this totals as follows: In the Northeast, \$485 million for 22 projects; in the Southeast, \$1.876 billion for 11 projects; in the Midwest, \$2.617 billion for 24 projects; and in the West, \$2.943 billion for 22 projects. The three states gaining the largest funding were California, \$2.25 billion for its planned high-speed rail network and \$94 million for conventional passenger rail; Florida, \$1.25 billion for the first phase of its planned Tampa-Orlando high-speed rail line; and Illinois, \$1.25 billion to effect speeds of up to 110mph on the existing line between Chicago and St. Louis, MO.

Of particular note related to short line and regional railroads is \$50.5 million to Vermont for track and structural improvements on the line between St. Albans, VT and the Vermont-Massachusetts line. That line is traveled by Amtrak’s daily “Vermont” train operating over the tracks of RailAmerica’s New England Central Railroad. News reports indicated that these and associated improvements could speed the train by as much as an hour as it travels through Vermont and Massachusetts.

PENNSYLVANIA NOW ACCEPTING APPLICATIONS FOR RAIL TAP FUNDING

The following message is addressed to the short line and regional railroads of Pennsylvania from the Southwestern Pennsylvania Commission:

The Commonwealth of Pennsylvania provides financial assistance to railroads operating in the state through two funding programs, the Rail Freight Assistance Program (RFAP) and the Rail Transportation Assistance Program (Rail TAP). **The Rail TAP program is currently accepting applications for funding, now through Friday Noon, February 12, 2010.**

Rail TAP, otherwise known as Capital Budget, is available to those having a line item in the current Capital Budget Bill. For those who do not have a line item, you should contact your local state representative or state senator to secure a line item. The project can be funded up to 70 percent of the total project costs, not to exceed the amount of the line item. The final grant award will be based upon actual bid costs or agreed upon prices if work is to be performed by your own labor forces.

CORN PRODUCTION POISED TO SET RECORD IN 2010

Progressive Railroading recently published an article that bears good news for railroads' grain traffic in 2010. The article highlights a report issued by the U.S. Department of Agriculture that projects an increase in corn production in 2010. A 1% increase is anticipated, which would bring corn production to a record 13.2 billion bushels in the coming year. The previous record for corn production came in 2007, with 13 billion bushels.

The increase in corn production is attributed to the use of "scientifically proven" biotechnology applications. U.S. Grain Council's Director of Biotechnology Programs Rebecca Fecitt said that, "We hope to see this upward trend in yields for U.S. corn continue."

In addition, the USDA projects sorghum production to increase to 383 million bushels, which is 19 million bushels higher than the previously projected amount in December 2009.

Mr. Wise succeeds Peter Rickershauser, who has announced his retirement effective April 30 ... **Canadian National recently announced the following executive appointments:** Keith Creel as EVP & Chief Operating Officer; Jean-Jacques Ruest as EVP & Chief Marketing Officer; Luc Jobin as EVP & Chief Financial Officer; Sean Finn as EVP-Corporate Services & Chief Legal Officer; Kim Madigan as VP-Human Resources; Robert Noorigian as VP-Investor Relations; Jeff Liepelt as SVP-Eastern Region; and Karen Phillips as VP-Public & Government Affairs ... **Canadian National has announced that it will make an initial donation of C\$100,000 to the Red Cross in support of the agency's relief efforts in Haiti, which suffered a major earthquake on January 12.** CN said that it would also match employee donations to the Red Cross dollar-for-dollar ... **Officials of Chicago's Chicago Region Environmental & Transportation Efficiency Program (CREATE) noted completion of another project of the program, the upgrading of McCook interlocking.** McCook locates approximately 13 miles west of downtown Chicago, where BNSF's Transcon Line crosses the CSX-Indiana Harbor Belt route between Blue Island and Franklin Park, IL. The upgrading allows trains to increase their speed through the interlocking from 10mph to 25mph ... **The Port of Seattle recently completed the purchase of the 42-mile BNSF line between Snohomish, WA and Renton, WA,** which runs via the east side of Lake Washington. The purchase price was \$81.4 million. BNSF will continue to provide freight rail service over the line, which is also slated for future commuter rail service and a bike and hiking trail alongside it ... **The Obama Administration has nominated Jeffrey Moreland to the Amtrak board of directors.** Mr. Moreland was a longtime attorney for the Santa Fe and then the BNSF, retiring in 2007 as the latter's executive vice president for public affairs ... **The U.S. Department of Transportation's Bureau of Transportation Statistics recently reported the final results of a 2007 commodity flow survey.** The report stated that rail movements that year totaled approximately 1.9 billion tons and 1.3 trillion ton-miles, representing 40 percent of all ton-miles. The report also stated that trucking accounted for another 40 percent of all ton-miles and that all rail, truck and water shipments totaled 12.5 billion tons and 3.3 trillion ton-miles ... **The U.S. Federal Railroad Administration has announced the appointment of Dr. Magdy El-Sibaie as its deputy associate administrator for safety, regulatory, and legislative affairs.** Dr. El-Sibaie, who was recently FRA's director of research and development and has most recently served as the acting associate administrator for hazardous materials of the U.S. Pipeline and Hazardous Materials Safety Administration, will succeed Grady Cothen, who has announced plans to retire from the FRA in March ... **The U.S. Railroad Retirement Board recently released its new Customer Service Plan.** The RRB's plan lays out its customer service standards and the levels of services that customers can expect. CLASS I RAIL TRAFFIC

For the week ending January 23, 2010, U.S. rail volume grand totaled 30.2 billion ton-miles, up 4.9 percent from the comparable period last year. U.S. carload rail traffic was up 2.9 percent, up 10.7 percent in the East, but down 0.2 percent in the West. Also for the week, U.S. intermodal rail traffic was up 2.9 percent, Canadian carload rail traffic was up 13.5 percent, Canadian intermodal rail traffic was up 7.4 percent, Mexican carload

rail traffic was up 29.8 percent, and Mexican intermodal rail traffic was up 41.6 percent.

For the period January 1 through January 23, 2010, U.S. rail volume grand totaled 84.4 billion ton-miles, down 2.5 percent from the comparable period last year. Also for this period, U.S. carload rail traffic was down 3.2 percent, U.S. intermodal rail traffic was up 0.9 percent, Canadian carload rail traffic was up 19.1 percent, Canadian intermodal rail traffic was up 4.4 percent, Mexican carload rail traffic was up 27.4 percent, and Mexican intermodal rail traffic was up 42.5 percent.
