## Congratulations to 346 ASLRRRA Railroad Members—Winners of Jake Awards for Safety

ASLRRRA has announced the winners of this year's [Jake Safety Awards](#), recognizing 346 member railroads as Jake Award winners. Of that number, 19 were recognized as [President's Safety Award](#) winners, and 316 received [Jake Awards with Distinction](#).

The Jake Award program recognizes member railroads for above-industry-average safety performance during 2020. To be honored with a Jake Award, an ASLRRRA-member railroad must perform better than the Class II and III industry average reportable injury frequency rate as recorded by the Federal Railroad Administration (FRA) during the calendar year, and must have completed all FRA-required employee-on-duty reporting for 2020. The average reportable Class II and III industry frequency rate for 2020 was 2.18 per 200,000 employee on-duty hours.

The 316 railroads receiving Jake Awards with Distinction had zero FRA-reportable injuries in 2020, while the 19 President's Award Winners are Jake Award recipient railroads that posted the lowest reportable injury frequency rate per FRA regulations as measured within man-hour categories.

“Safety is the number one priority on every railroad. Our member railroads are focused not only on compliance, but on creating a strong safety culture where each employee feels accountable for safety, day in and day out,” said Chuck Baker, President of ASLRRRA in a [press release](#). “This year ASLRRRA member railroads reduced their injury rate by 10%, significantly outpacing the overall industry decline of 8% in an impressive year for railroad safety. That includes a record 316 ASLRRRA member railroads receiving Jake with Distinction Awards reflecting zero employee-on-duty accidents on their railroads in 2020. This is a testament to each member's focus on operating safely in spite of a disrupted and uncertain supply chain during the pandemic; investment in maintenance and new technology; and to the Short Line Safety Institute, which has provided significant leadership in the area of safety culture to short line railroads.”

The Association applauds this year's President's Award winners, who will receive their awards at the [Central and Pacific Region Meeting](#) in Kansas City, Mo. and the [Eastern and Southern Region Meeting](#) in Louisville, Ky. ## ASLRRRA Welcomes New Assistant Vice President of Congressional Affairs



ASLRRRA is excited to welcome Zachary M. Radford, the Association's new Assistant Vice President of Congressional Affairs. He will report to ASLRRRA's Vice President of Congressional Affairs Tom Lynch.

As part of the congressional affairs team at ASLRRRA, he will work with the association staff and the member short line railroads to pursue legislative support for critical issues facing short lines, including infrastructure grant programs and surface transportation and tax policy.

"Zach brings significant transportation legislative experience that will serve the Association and its members well - and immediately - as Congress works to bring a transportation or broader infrastructure bill to the President's desk," said Chuck Baker, President of ASLRRRA. "I've

known Zach for many years, initially working with him back when he was the transportation staffer for Senator Blumenthal of Connecticut, a key member of the Senate Commerce Committee. His work was always relentless, creative, and of the highest integrity. Zach's immersion in transportation and infrastructure issues from his time serving two Senators, his government affairs work with WMATA, and standing up the Washington Metrorail Safety Commission have uniquely positioned him to dive right in, helping to move short line issues forward in D.C."

Mr. Radford has provided leadership in advocacy, strengthened stakeholder ties, and tackled legal and regulatory challenges in the transportation sector in many roles. In Congress, Mr. Radford served U.S. Senator Richard Blumenthal as Senior Policy Advisor & Counsel, influencing rail safety bills, the 2015 FAST Act and the 2018 FAA Reauthorization. Mr. Radford also served as a legislative assistant to Senator Jon Tester, advancing the Senator's Appropriations Committee work among other responsibilities. In addition, Mr. Radford has served a Federal Relations Officer at the Washington Metropolitan Area Transit Authority, Director of External Relations at the Washington Metrorail Safety Commission, and as a private consultant. Previously, Mr. Radford practiced law in California.

"I'm pleased to be joining the organization at such a critical time, especially as Congress considers infrastructure legislation that will impact the short line industry for years to come," said Mr. Radford. "I look forward to ensuring that the short line freight industry is well considered as key policy decisions are made, so our members can continue to serve as the vital freight connection linking small-town and rural America with our national network."

Radford received his bachelor's degree from Georgetown University, and his Juris Doctor from the Washington University in St. Louis.

### RRB Q&A Explains Railroad Retirement Survivor Benefits

In the [May installment](#) of its question-and-answer series, the Railroad Retirement Board (RRB) focuses on survivor benefits.

In certain cases, surviving widow(er)s, children and some other dependents of railroad employees can receive monthly benefits if the employee was “insured” by the Railroad Retirement Act at the time of death. Lump-sum death benefits can also be paid in some

circumstances.

A key point to note is the requirement that the deceased employee must have been “insured” under the Railroad Retirement Act. To be insured, the employee must have had at least 10 years of railroad service, or five years performed after 1995, and a “current connection” with the railroad industry based on the month the annuity begins or the month of death, whichever happens first.

The Q&A goes on to define a “current connection” and explain the eligibility requirements for surviving spouses in different situations, such as those who have or have not remarried and divorced spouses. It also describes when children and other dependents are eligible for benefits, and how survivor benefits might be subject to reduction or affected by receipt of other benefits.



## **Training Videos Help ASLRRRA Members Remain Compliant with FRA Requirements**

ASLRRRA is dedicated to railroad safety and compliance and strives to assist members with industry best practices and compliance throughout their operations by offering essential resources, including [training videos](#) that are available as a direct download from the association website.

The [Post-Accident Toxicological Testing Video](#) is an industry-produced interactive training video that provides instruction on when and how to administer a post-accident drug and alcohol tests. Federal Regulation Part 219.11(g) requires Post-Accident Toxicological Testing (PATT) training for supervisors of regulated employees. This PATT eLearning course has been reviewed by the Federal Railroad Administration (FRA) and will ensure compliance with the PATT training requirements.

The [Reasonable Suspicion Drug & Alcohol Signs and Symptoms Video](#) provides detailed direction on drug and alcohol testing guidelines. This video teaches railroad workers how to recognize possible impairment, what substances to test for, how to conduct a proper test, and steps to take in case of a positive test, among many other components. Part 219.11(g) requires signs and symptoms training for supervisors of regulated employees. Training with this video will ensure compliance.

### Gitcheell to Join Rebuild Rural Coalition Meeting with Biden Administration and Agency Representatives

ASLRRA's Assistant Vice President of Legislative and Regulatory Policy Crystal Gitcheell will participate in a Rebuild Rural Coalition meeting with members of the Biden Administration to discuss the administration's infrastructure proposal and priorities.

The meeting will include representatives from a number of federal agencies, and participants will have the opportunity to submit questions to specific departments and agencies regarding rural infrastructure. ASLRRA plans to make the needs of rural short lines known, and will follow up with those at the meeting to keep the conversations going forward.

The National Economic Council (NEC), Domestic Policy Council (DPC), Department of Transportation (DOT), Department of Commerce (DOC), National Telecommunications and Information Administration (NTIA), United States Department of Agriculture (USDA), Environmental Protection Agency (EPA), Department of Energy (DOE) and Department of Housing & Urban Development (HUD) are all scheduled to participate.

ASLRRA continues its relationship with the Rebuild Rural Coalition through meetings and calls with key staffers in the federal government. The coalition brings together rural stakeholders in the transportation, health, technology and education sectors.
