About the ASLRRRA Fall Super Regional Meeting

The ASLRRRA Fall Super Regional Meeting brings together ASLRRRA Board and Committee Members, Railroad Members, Class I railroad representatives, Associate/Supplier Members, government employees, and non-members from across the country. The program will feature more than 20 educational sessions. In conjunction with the meeting, ASLRRRA Boards and Committees will convene, and Regional Sandhouses/Board Meetings will be held for each region. Keynote presentations, Class I speakers, and panel discussions will take place during General Sessions. Key networking opportunities will be incorporated.

Important Submission Guidelines and Speaker Expectations

- All speakers must be current ASLRRRA members in good standing.
- Speakers must be available to present in person at the 2026 Fall Super Regional Meeting, October 5–7. Sessions may be scheduled at any time during the event.
- Each proposal may include a maximum of four (4) speakers and one (1) moderator, for no more than five (5) presenters in total.
- Session format is 50 minutes per session and may be either a theater-style room with projector and screen or an interactive roundtable discussion.
- Proposals must include a clear and concise session title (maximum 8 words) and a persuasive, outcomes-focused description (maximum 150 words). ASLRRRA reserves the right to edit titles and descriptions for marketing purposes and space constraints.
- All proposals must be educational in nature and free from commercial bias. Proposals resembling sales presentations will not be selected. Speakers found in violation of this policy may forfeit future speaking opportunities.
- Associate/Supplier Members are encouraged to partner with a Railroad Member to provide a practitioner-based perspective.

- Speakers with accepted proposals are expected to register for the conference at the discounted speaker rate and are responsible for their own travel and accommodation.
- Additional information will be provided in July for speakers who are selected to present.
