Dear Chairman Schatz and Ranking Member Hyde-Smith:

We write today to request that the subcommittee provide robust funding for the Consolidated Rail Infrastructure and Safety Improvements (CRISI) program in the FY24 Transportation, Housing and Urban Development, and Related Agencies Appropriations bill.

In 2015, Congress created CRISI as a wide-reaching program that could fund rail research at universities, training programs for workers, and safety and other capital improvement projects along passenger rail lines and short line freight railroads. This flexibility has been key in allowing a variety of crucial projects to move forward that have enhanced the overall safety and efficiency of our Nation's rail systems.

In particular, CRISI has been a valuable resource for the first-mile and last-mile movement of freight, which is an integral part of our supply chains. Agricultural producers and industrial manufacturers rely on this service to get their goods to market, and CRISI has helped fund projects that mitigate congestion, remove bottlenecks, and increase efficiency.

Since 2017, CRISI has invested \$1.5 billion in projects across 47 states and the District of Columbia. This track record of success led to a substantial increase in CRISI's funding levels in the IIJA. The bipartisan infrastructure law provided \$1 billion per year in advance appropriations for CRISI, as well as an additional \$1 billion per year in authorizations.

The FY24 President's Budget Request included a \$510 million request for CRISI. While this is a significant investment, additional dollars will improve safety and service for all. We urge you to further expand the program's potential and provide robust funding in FY24. A well-funded
